

## ANTI-RAGGING COMMITTEE

Ragging is a Crime offense. Ragging is strictly prohibited by both state Govt and Central Govt. Punishment for ragging will be as follows:

- (i) Imprisonment upto three years and fine of Rs. 50,000/-
- (ii) Dismissal from the college

As per the orders of the Supreme Court of India and subsequent Notification from University Grants Commission (UGC), ragging constitutes one or more of any intention by any student or group of students on:

\* Any act of Indiscipline, Teasing or Handling with Rudeness.

\* Any act that prevents, Disrupts the Regular Academic Activity.

\* Any activity which is likely to cause Annoyance, hardship, Psychological Harm or Creates fear or Apprehension

\* Any act of Financial Extortion or forceful Expenditure

\* Any act of Physical Abuse causing Assault, Harm or danger of Health

\* Any act of abuse by Spoken words, emails, SMS or public insult etc

\* Any act of injury or infringement of the fundamental right to the human dignity.

\* Any Act of Wrongful Confinement, Kidnapping, molesting or committing unnatural offences, use of Criminal forces, trespass or intimidation.

\* Any unlawful assembly or conspiracy to ragging.

### VISION

Anti-Ragging ensures to create an atmosphere of a sensitive and liable outlook amid the students about the cause and effects of indulging in ragging.

## MISSION

Anti-Ragging Committee to ensure Compliance with the provisions of Regulations as well as the provisions of any law for the time being in force concerning ragging; and also, to monitor and oversee the performance of the Anti-Ragging Squad in prevention of ragging in the institution.

## OBJECTIVES

The main objectives of the Committee are as follows

\* The Anti-Ragging Bearers work under the supervision of Anti-Ragging Committee and to engage in inspecting places like Buses, Canteens, classrooms and other places of student gathering.

\* In designing strategies

\* for curbing the Menace of Ragging in College

\* Conduct awareness programs in the campus on regular basis.

## FUNCTIONS

\* Form Anti-Ragging Committee consisting of senior faculty and headed by Principal.

\* Committee has taken steps and allotted duties to all the staff members at almost all areas in the college (i.e. canteen, parking, different blocks, play grounds etc) and ensure that atleast one faculty member will be present at any particular time at all the location to avoid ragging activities.

\* Committee has taken precautions to avoid ragging activities at other locations like bus stops, give instructions and appointed student volunteers and secrete informers at various boarding points.

\* Wide canvassing about anti ragging, is being done in the forms of flexes, posters and boards in college premises and surrounding areas where there is a chance of ragging.

\* Grievances and Redressal Committee is also made part of these anti-ragging activities

\* Many awareness programmes about anti-ragging will be conducted by anti-ragging committee in the form of meetings

### ROLES & RESPONSIBILITIES

\* To ensure compliance with the provision of UGC regulation 2009 at the institute level.

\* To monitor and oversee the performance of Anti-Ragging in prevention of ragging in the institution.

\* To publicize to all students about the preventive directives and the actions that can be taken against those indulging in ragging.

\* To consider the complaints received and submit the report to Anti-Ragging committee along the punishment recommended for the offenders.
