1. Purpose of MoU

- d. The Party I will coordinate, facilitate, and/or provide all facilities which will assist in successful completion of E-Waste Management Audit of Anubose Institute of Technology.
- e. The Party 2 will implement the visits in any manner within its authority.
- f. In case of breach (delay) Party 2 of the terms of this agreement the Party I may unilaterally, by serving a written notification, terminate this MOU and ensure works through some other party (ies) as a result of such termination.

5. Duration and Termination.

- a. This MoU shall enter into force from 14-09-2023 the moment of its execution and shallremain in full force till 13-09-2028, the achievement of the Purpose.
- b. The MoU may be terminated by parties by terminating its involvement in the activities set out in this MoU. Such termination shall be in writing to all other Parties and should not result in any kind of liability towards the other Parties
- c. Party 2 shall recoup all the liabilities created under this agreement and the other Parties' obligations that shall survive on termination or expiration of this MoU.
- d. Under no circumstances, whether as a result of breach of agreements, warranty, guarantee, indemnity, tort (including negligence), strict liability or otherwise, shall

6. Amendments

- a. This MOU may be amended by written agreement of the parties.
- b. If any provision of this MOU becomes invalid or unenforceable, the validity of otherprovisions shall not be affected.

7. Notifications

Any correspondence sent by the parties within the framework of this MOU shall be made in writingand shall be sent by mail, courier service or facsimile transmission (with the original to follow).

8. Governing Law

Member ENVIRO COLLECTION CENTRE shall endeavour to settle any disputes arising by negotiation betweenthe Parties, whose decision shall be final and binding.

2. Scope:

- While this agreement is in force, Anubose Institute of Technology shall ensure that all
 the dry recyclables will be disposed only through For and on behalf of EWMS PVT LTD
 or its associated partners.
- Rates for recyclables will be displayed time to time on Recycle.
- Anubose Institute of Technology will raise invoices of the For and on behalf of EWMS PVT LTD to be received against the disposal of recyclable.
- The sustainability certificate for responsible disposal through the EWMS PVT LTD will be provided and the same can be accessed on For and on behalf of EWMS PVT LTD dashboard.
- Anubose Institute of Technology is required to provide necessary entry and exit permissions included, but not restricted to gate-pass, other access formalities to use its space for loading of recyclable and man power movement during the time of pickup.

The Project shall be valid till 13 SEPTEMBER 2028 and can be renewed for additional periods and quantities as per mutual agreement of Anubose Institute of Technology & EWMS PVT LTD

3. Indemnity:

Anubose Institute of Technology shall be solely responsible for collection & storage of category wise recyclables in their premises. ENVIRO WASTE MANAGEMENT SERVICES PVT LTD will share its expertise for segregation of this material.

- (3) In the event of any lapses in execution by any party, the other partyshall have the right to terminate this agreement by giving a 30 days notice to the defaulting party.

5. Amendment:

Any Amendment to this Agreement shall be valid and binding on the Parties only if it is made in writing and signed by duly authorized representatives of each Party.

6. Notices:

Resolution of Disputes:
